

AN EVIL PRESIDENT CHOOSES HIS EVIL DOCTORS TO IMPLEMENT HIS EVIL HEALTH PLAN

For the first time in our nation's history, a slim majority of frightened, self-righteous and foolish Americans elected its first racist, traitorous and diabolical President. And in no other area, does the true nature of the White House occupant become clearer, than in his health care bill snaking its way through Congress.

This is more than a "health bill." It is the culmination of the dormant American Eugenics program that in the 1920's and 30's, was spearheaded by the new American Progressive movement. Under a utilitarian philosophy placing society above the individual, it sterilized thousands of poor white West Virginia residents in order to test out a program for "purification" of the population. While curtailed in the United States, It was a blueprint for much of what happened in Nazi Germany.

But Eugenics seems to have raised its head again in the form of Obama's national health plan and the people that will administer its plans for "culling" the elderly and sick. It even has its racist overtones because Blacks will be a favored group under Obama's Black Liberation Affirmative Action Reparations plan.

Normally, progressive Eugenics knows no racial, religious or ethnic borders. It is a philosophy of social purification based on eliminating the most physically weak and vulnerable in our society. This is shown to be true in that two of the Physicians developing the program are Jews who should know better, based on their own ethnic group's experiences. That the racist President Barack Hussein Obama has built in his Affirmative Action to offer preferences to Blacks, displays the true nature of a race-based Presidency.

Doctor Ezekiel Emanuel is brother of White House Chief of Staff Rahm Emanuel. Under the Obama Administration, Dr. Emanuel was appointed to the positions of Health Policy Advisor to the Office of Management and Budget and member of The Federal Council on Comparative Effectiveness Research. Both positions will quantify health care with cost, reducing human life to a number on a spreadsheet.

Emanuel is not a politician and as such, does not mince words. In Health Affairs Magazine (February 27, 2008), he readily admitted, "Vague promises of savings from cutting waste, enhancing prevention and wellness, installing electronic medical records and improving quality are merely 'lipstick' cost control, more for show and public relations than for true change."

It seems that in Obama's dark world, "Change," offers more than rainbow colored buttons and mindless expressions. It's more akin to the 1970 movie "Soilent Green," starring Charlton Heston, where the unnecessary population was ground up and used to feed a less expendable populace as determined by the state.

"Savings," Emanuel writes, will require changing how doctors view their patients. Emanuel feels that Physicians take their Hippocratic Oath too seriously, "as an imperative to do everything for the patient regardless of the cost or effects on others." This, the alleged Physician wrote in The Journal of the American Medical Association, of June 18, 2008.

It is here that Dr. Emanuel does a linguistic spin on the term "Communism," by calling this Eugenics revival "communitarianism." It is this neo-Nazi philosophy that he designates as the guide for decisions on just who gets medical care.

Under the Obama Presidency, medical care will be reserved for the non-disabled and as Dr. Emanuel writes in the Hastings Center Report of November-December 1996, not given to those "who are irreversibly prevented from being or becoming participating citizens."

And if you have any doubts of where the Obama medical universal Eugenics "health plan," will take us, Dr. Emanuel clarified his position in this year's Lancet Medical Journal of January 31st. He explicitly defends discrimination against older patients: "Unlike allocation by sex or race, allocation by age is not

Invidious discrimination; every person lives through different life stages rather than being a single age. Even if 25-year-olds receive priority over 65-year-olds, everyone who is 65 years now was previously 25 years."

For anyone who doesn't grasp the implications, it means that there is no discrimination, because everyone eventually winds up on the chopping block... unless you are a member of Obama's privileged class. And if you still can't come to grips with this concept, partial funding to the tune of some 400 billion dollars will be pulled from Medicare.

For decades, most medical innovation has come from American laboratories. But this is also about to change as reduced development funds will be used to target those people, determined to be of most use to The Federal State.

Another of Obama's medical dogs is Dr. David Blumenthal. Like Obama, he is a proponent of targeted research to control medical costs to benefit the healthy young and privileged. If there is dementia in the elderly, it is in their support of Barack Hussein Obama.

Blumenthal has long advocated government health-spending controls, though he concedes they're "associated with longer waits" and "reduced availability of new and expensive treatments and devices." He even had the nerve to write this in The New England Journal of Medicine, of March 8, 2001. He considers it "debatable" whether timely care for Americans is worth the cost. If immediate care is so crucial, why not let them die and save money for the new American Authoritarian State.

Obama appointed Blumenthal to be National Coordinator of Health-Information Technology. It is a watchdog group designed to ensure that America's physicians toe the line and don't fall into petty sentimentality such as concern for the sick. In Obama's Progressive Utilitarian State, cost benefit replaces the Hippocratic Oath.

In the April 9, 2009 New England Journal of Medicine, Blumenthal predicted that many doctors would resist "embedded clinical decision support," or physicians being guided by computer directive from a Washington bureaucracy.

To an America of "Change," dominated by Barack Hussein Obama and his gang of utilitarian physicians, "the little people," have become spoiled by our nation's excellent medical care.

Would Barack Hussein Obama subject his own family to this treatment? He was asked just that at a town hall meeting on June 16, 2009 by a Jewish neurologist named Devinsky, from New York University Langone Medical Center. Obama could barely control his contemptuous laughter and gave an emphatic no.

And if you think Blacks won't be given a slide in this treatment in Obama's "Brave New World" of American medicine, his plan has an "Office of Civil Rights," and "Office of Minority Affairs." All Blacks have to do is claim racial discrimination and these government health plan divisions become their advocates. An operation for a white person is placed on hold and the black person is pushed to the head of the medical line.

Not only that, but the bill has race quotas for less qualified Blacks to attend medical schools. Obama doesn't care if highly qualified white and Asian Physicians leave the profession. He wants to pack the medical field with less qualified Black doctors as part of his back door reparation's program. Even more diabolical, every five years, Seniors over the age of 65 will be required to attend counseling sessions on "alternatives" to receiving medical treatment
